ADVICE TO COUNCILLORS:

(There is an exemption from having to declare "sensitive information"; the Clerk can advise you about this).

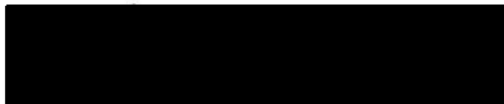
